

Energy Star Appliances Rebate Application

REBATE POLICY

CMLP is offering a rebate to residents who replace inefficient appliances with Energy Star-rated models for use in their Concord residence. Energy Star ratings certify that an appliance meets certain standards of energy efficiency. The \$200 rebate is only available for refrigerators on the current "Energy Star Most Efficient" List, found at: www.energystar.gov/products/most_efficient/refrigerators. The \$400 rebate is available for any Energy Star-rated clothes washing machine. Installation labor is not eligible for rebate funds. The best time to upgrade appliances is during home renovations, or if appliances are over 10 years old. Refrigerators commonly have a year of manufacture sticker on the inside. This rebate does not apply to clothes dryers or dishwashers. Only one rebate / equipment type / household / year. This rebate available for purchases or work done from 2/5/17 - 6/30/18, while funds last. Rebates under \$500 are issued as a credit on your electric bill and rebates over this amount are mailed as checks from Town.
