Clothesline Rebate Application

REBATE POLICY

The Town of Concord is offering a rebate for residents who install clotheslines or drying racks at their Concord home. Residents will receive up to \$50 for the purchase of eligible equipment and the cost of installation (if applicable) to replace or reduce the use of electric or gas clothes dryers. This includes clotheslines and drying racks, such as outdoor umbrella racks or indoor laundry racks. Only one rebate per equipment type per household per year. This rebate is available for purchases or work done from 2/5/17 - 6/30/18, while funds last. Rebates under \$600 are issued as a credit on your electric bill and rebates over this amount are mailed as checks from Town.
